Background

The Guardian Angel Award for Philanthropic Leadership was established in 1999 to recognize the work of individuals and/or a group of individuals, in Hastings, Northumberland and Prince Edward Counties, in encouraging private action for the public good through philanthropy.

Selection & Recognition

The Board of Directors of The Children's Foundation will review all nominations and select the award winner. The recipient will be honored at the Annual Guardian Angel Gala.

Nominees Must:

1. Reside or work in Hastings, Northumberland or Prince Edward Counties.
2. Have an extensive history as a volunteer leader within the community.
3. Use his/her influence within the corporate, industrial, and private sectors to solicit and/or make significant philanthropic gifts.
4. Be a guiding force within the community.
5. Demonstrate compassion for children/youth and all people in need.
6. Long-standing dedication to charitable work with The Children's Foundation, and other organizations with a focus on children and youth.
7. True philanthropic spirit, with selfless motives.

Nomination Process / Guidelines

1. Nominations will be accepted for individuals, couples or groups involved in giving their private resources and/or leading and motivating other individuals to give their personal resources for the betterment of society, specifically children.
2. Attach to the Nomination Form no more than three pages of narrative that describe:
 - a) **Commitment:** Information about the nominee's personal giving experience within the social service sector and The Children's Foundation
 - b) **Leadership:** How the nominee has demonstrated leadership in their philanthropic activities
 - c) **Impact:** Three to five ways in which the nominee has made a difference in our community, region, or province, in strengthening our society, especially for children
 - d) **Creativity/Advocacy:** The nominee's support of innovative ideas in the non-profit and public sectors
 - e) **Collaboration:** Examples of how the nominee works with the grantees or other donors to support common goals
3. Please submit the enclosed typed nomination form, including contact information for two individuals who can serve as references for the nominee. The references should have a comprehensive knowledge of the nominee's background, accomplishments, and community impact. References will be contacted for the final candidates only.
4. Public officials, organizations and staff of philanthropic organizations are not eligible for nomination.
5. Nomination deadline is Friday, June 7, 2019.
